Key differences between A3 and A5

Microsoft 365 A3 and A5 are education-specific, enterprise-level **Microsoft licensing** options that include Office 365 (O365), Windows 10 and 11, and Enterprise Mobility and Security (EM&S) services. All of the core capabilities are the same, but A5 has advanced **security** and compliance features.

The core capabilities include:

- O365 A3 - Including M365 Apps, One Drive, SharePoint etc
- EM&S A3 - Including Intune P1 and Entra ID P1
- Windows 11
- Remote help
- Defender for Endpoint P1
- Minecraft for education

Additional features included in A5

Better compliance and data governance

With strict regulations and governance requirements, schools, colleges, universities, and research institutes must ensure compliance with data protection laws. A5 provides more advanced compliance tools to help manage and safeguard sensitive information, reducing legal and financial risks.



Sentinel offer

Microsoft 365 A5 customers receive a data grant of up to 5 MB per user per day for data ingestion into Microsoft Sentinel.

This grant covers various data sources, including Microsoft Entra ID (formerly Azure AD) sign-in and audit logs, Microsoft Defender for Cloud Apps logs, Microsoft Purview Information Protection logs and Microsoft 365 advanced hunting.



Ramp offer benefits

In August 2024, Microsoft made changes to the Storage Allowance which heavily impacted educational institutions.

Currently, all education tenants receive 100TB of free pooled storage across OneDrive, SharePoint, and Exchange. Additional storage will be allocated based on the number of paid users with 50GB per A3 user and 100GB per A5 user.

Framework Benefits – JISC

Education customers can also join the JISC framework which provides further discounts to the A5 products. These discounts are designed to help educational institutions to adopt comprehensive A5 coverage and security solutions.

The JISC framework is available to customers which have a minimum of 100 Education Qualified Users (EQU). And under this framework there is various discounts across the A5 Security and Full A5 suites to suit different educational institutions and their needs.

Student use benefit and how it differs from Faculty M365 A5

When educational institutions purchase an M365 A3 or A5 licence, they are then entitled to the M365 Student Use Benefit licence of the version they have purchased.

Each institution is entitled to a ratio of 1:40 student use benefit licences. What this means is, for every A3 or A5 licence they purchase they will then receive 40 M365 student use benefit licences free of charge.

For example, if an institution purchased 100 M365 A3 licences, they would receive the below:

100 M365 A3 Faculty Licence x 40 = 4000 Student Use Benefit Licences

However, as the student use benefit licences are free, the features aren't fully reflective of the paid for licences.

The most noticeable difference for customers is that Defender for Endpoint Plan 1 or Plan 2 are not included. However, there is a special Defender for Endpoint Per Device SKU which allows for estate wide protection for all shared devices.
